Led riders must only train over poles on the ground and **MUST NOT** jump grade 5 or 6 obstacles. All grade 6 and 'pole on ground' riders must have an adult accompanying them on the cross country course.

This is an opportunity for riders to try out some cross country and show jumping without the pressure of a competition.

EA riders welcome. EA members will ride under PCASA rules and a waiver form must be completed prior to riding. Please note: a \$10 fee will apply.

Fences will be flagged.

#### Cross country:

Grade 5 (50cm): 8.30 – 9.30  
Grade 6 (30cm): 10.30 – 11.30  
Pole on ground: 9.30 - 10.30

#### Show jumping

Pole on ground: 8.30 – 9.15  
Grade 6: 9.30 – 10.15  
Grade 5: 10.30 – 11.30

#### CONDITIONS OF ENTRY

A Pony Club approved body protector is now mandatory for ALL RIDERS. Medical armbands must be worn. If you don't have one, please report to the office and fill out a substitute form.

Proof of financial Pony Club Membership is required, so remember to bring your Performance Card or proof of current financial membership.

**PLEASE NOTE:** There will be an additional \$10 fee for EA members and a waiver form must be signed on the day.
