N.B. All clubs must ensure they have an INCIDENT record book and fall forms on hand for the ODE - ONLINE INCIDENT REPORTS must also be completed (available on the PCA website)

Organizers please note courses are inspected 6-4 weeks prior to an event at the request of the organizers if the course has not been in use for some time. Preliminary inspection at least 1 week prior to the event (if the event is run over two days the course should be inspected day before cross country phase) & then immediately prior to the course being open to the riders.

# **NOTES FOR ORGANISERS**

All schedules/program/entry forms must be submitted to PCASA for proofreading prior to distribution (only approved programs can be distributed

#### THE PONY CLUB ® TECHNICAL DELEGATES REPORT

Once request for Technical Delegate is received the person nominated to appoint them will see who is available, when possible TD is found they will be contacted either by email or phone to confirm availability, when a person is appointed to an event they will be listed next to that event on the PCASA webpage.

#### **ORGANISERS**

Ensure completed list of all results is forwarded to the state office with **payment of ODE levies within 14 days**. Make sure you retain a copy for your records.

It is necessary to provide a designated car parking area – no horse floats or horses to be in this area.

#### **ODE LEVIES** (payable on all events that require a Technical Delegate)

Levies must be paid for all riders – within 14 days of the event

All Pony Club® Riders \$4.40 each combination until 30/6/2024, \$6.60 each combination from 1/07/2024.

EA riders \$15.00each (if Open classes held for EA&/or PCASA riders)
Eliminations must still be paid for. The only exceptions are scratchings prior to the event

#### **DUTIES OF A PONY CLUB TECHNICAL DELEGATE (PCTD)**

The PCTD has the following duties and responsibilities from the time of appointment until the conclusion of the event.

- 1. To ensure that competitions are run in accordance with the rules.
- 2. To inspect the courses and arenas, before they are shown to the riders, and to satisfy themselves that the technical details are in accordance with the rules.
- 3. To satisfy themself that the course is fair.
- 4. They have the authority to instruct the Organising Committee and the Course Designer to make any alterations to the arena or to the course, or to any technical detail associated with the conduct of the competition that they consider necessary.
- 5. To help the organisers in the conduct of the competition and endeavour to resolve problems wherever possible.
- 6. To advise the Disputes Committee and Appeals Committee (as the case may be) in relation to any dispute particularly as to any rules which apply? The Pony Club® Technical Delegate must not interfere in the decision-making process of the Disputes Committee and must not attempt to unduly influence its decision making.
- 7. To mediate on competitor problems where possible. (Hold rider briefing)
- 8. Ensure incident reports and fall forms are completed for all falls/accidents.
- 9. Ensure report is completed and forwarded to PCASA State office within 14 days.

#### **DUTIES OF THE ORGANISERS**

Organisers must provide the Pony Club® Technical Delegate with suitable accommodation and meals.

#### BODY NUMBER HOLDERS - MEDICAL ARMBANDS - BODY PROTECTORS

Body number holders are **compulsory**. All riders are required to wear a body number, and medical armbands, regardless of class entered. Organisers are requested to purchase a quantity to keep on hand for sale. From 1/7/2022 Body Protectors as per PCA national gear rules are **COMPULSORY** when jumping any fixed fence.

#### IMPORTANT RULE CHANGES

Ensure that you have a **rule book** for the current year.

**NOTE:** On all entry forms PIC number is required as per PIRSA entry information to be held for 1 month then destroyed. This is a biosecurity measure in case a problem with a horse is detected; PIRSA can then check what animals had been in contact with it.

**PCASA ODE/STATE ODE CHAMPIONSHIPS** – Host Zone/Club to refer to appropriate section of current PCASA rule book.

#### **DRESSAGE SCORING (FROM FEI RULES)**

The good marks from zero to ten (10) awarded by each Judge to a competitor for each numbered movement of the Dressage Test together with the collective marks are added together deducting any error of course or test. (1/2 marks are allowed under PCASA rules – from 1/8/19)

For each Judge the percentage of maximum possible good marks obtainable is then calculated. Percentage is obtained dividing total good marks and errors of the Judge by maximum possible good marks obtainable and then multiplying by 100 and rounding the result to two decimal digits. This value is shown as the individual mark for that Judge. Rounding the result to two decimals includes any score of "x.xx5" and above is round up and any score less than "x.xx5" in rounded down.

Athlete's percentage is calculated on the average good marks and errors obtained by adding together the total good marks for each Judge and dividing by the number of Judges. The Athletes percentage will always be rounded to two decimal digits.

In order to convert Athletes percentage into penalty points, this must be subtracted from 100 with the resulting figure being rounded to one decimal digit. The result is the score in penalty points for the test.

#### 6. LOSS PREVENTION AND CONTROL

Loss, prevention and control are primarily concerned with pre-loss consideration – not post loss "patching up". Loss Prevention and Control is as the name states – it seeks to identify and evaluate risks before they become losses.

Members of a Club Committee have the responsibility to protect and manage the Event properly. As such, it is necessary to them to carry out the ongoing role of risk identification and evaluation to protect and prevent personal injury and suffering before the damage or injury occurs.
