## **GENERAL INFORMATION**

All classes will be run under PCASA rules.

- Pony Club classes are open to members of PCASA affiliated Pony Clubs, PC combinations must have 4 qualifications to be able to compete (see PCASA rules)

- Open classes are open to EA and PCASA State Adult Members, an additional \$15 PCASA levy per rider applies.
- ODE competitors are asked to nominate a helper to assist with cross country jump judging. All jump judges are required to attend a briefing at approx. 8am Sunday morning.
- PC riders and PCASA State Adults must present a current PCASA card to the event Secretary prior to the start of the event.
- EA riders must show proof of current EA membership, and sign waiver.
- PCASA rules for Conduct of One Day Events will apply in all classes.
- Approved helmet, body protector, riding boots and gear must be worn by all competitors. See PONY *CLUB AUSTRALIA NATIONAL GEAR RULES.*
- A Medical arm band and A4 size body number holder must be worn for cross country. *Riders are to provide their own.*
- Gear Check compulsory for all riders prior to commencing each phase of the competition.
- Entries are limited and will be accepted on a first come basis.

**CATERING:** Catering is available on both days including breakfast

**CAMPING:** Camping is available on the grounds from midday Friday, Fee \$30 per site for the weekend and can be booked on entry with NOMINATE

**YARDS:** No yards available

**REFUNDS:** No refunds after closing date without a vet or doctor's certificate. Requests for refunds must be submitted within 7 days of the event and will incur a \$20 administration fee.
